For AmBank (M) Bhd Vehicle Please take note that:-

New Processes On JPJ Transfer of Ownership for Auctioned Motor Vehicle

1. Option 1 – For Cases whereby Successful Bidder Unable to Obtain 'Butir-Butir Kenderaan' from Jabatan Pengangkutan Jalan (JPJ).

Upon settlement of the balance of the purchase price, successful bidder are to request for AmBank Officer to purchase the 'Butir-Butir Kenderaan' from Jabatan Pengangkutan Jalan (JPJ) for which the sum of **RM20.00** to be issued by way of Money Order (MO) made payable to **Akauntan Negara Malaysia-MOT-T** and forward to AmBank Head Office for their further attention.

Upon received of the money order, AmBank officer will prepare the relevant documents such as:-

- i. Letter of Authorisation from AmBank to purchase the "Butir-Butir Kenderaan";
- ii. Copy of Fourth Schedule Notice (4th Schedule);
- iii. Copy of Fifth Schedule Notice (5th Schedule)
- iv. Copy of Police Report (if required)
- v. Money Order amounting to **RM20.00** payable to **Akauntan Negara Malaysia-MOT-T** and submit to JPJ to obtain the "Butir-Butir Kenderaan". The same will then be forwarded to the successful bidder for the purpose of obtaining Puspakom B5 Inspection Report.

Option 2 – For Cases whereby Successful Bidder be able to obtain the "Butir-Butir Kenderaan"

The successful bidder will only require AmBank to provide them with the relevant documents required as stated above except for item (v) where the payment to be made direct to the respective JPJ. Successful bidder to proceed with Puspakom B5 Inspection Report upon obtaining the "Butir-butir Kenderaan".

2. Once Puspakom B5 Inspection conducted, the report are to be forwarded to AmBank together with the following documents to be submitted to JPJ for transfer of ownership purposes:-

- i. Copy of Successful Bidder MyKad (for individual) or SSM Borang 13 & 'Lesen Berniaga' (for company);
- ii. Money Order amounting to **RM100.00** made payable to **Akauntan Negara Malaysia-MOT-T** for transfer of ownership fee.

Upon received of the above documents, AmBank Head Office representative will submit the same to JPJ together with the following documents to affect the transfer:-

- i. Letter of Authorisation from AmBank;
- ii. Puspakom B5 Inspection Report;
- iii. Copy of successful bidder MyKad (for individual) or SSM Borang 13 (for company);
- iv. Copy of AmBank's representative MyKad;
- v. Copy of Fourth Schedule Notice (4th Schedule);
- vi. Copy of Fifth Schedule Notice (5th Schedule)

Upon transfer of ownership affected, the Vehicle Ownership Certificate (VOC) will be delivered to the respective auction house for the successful bidder to collect them accordingly.
