X Star Technology Malaysia Sdn Bhd Auction Vehicle.

TERMS AND CONDITION

Please pay attention to the following items before bidding auction vehicles.

1. Vehicles auctioned are on “as-is where is” basis without any warranty as vehicles auctioned are used and repossessed vehicles.
2. All vehicle without original of VOC / Registration Card.
3. All bidders are reminded and forewarned to inspect the vehicle thoroughly check and verify the identity of the vehicle such as blacklisted by police / JPJ before proceed to bid.
4. Successful bidders are required to conduct Puspakom Inspection on the vehicle before taking out from the storeyard. The cost of inspection shall be borne by successful bidder.
5. X Star Technology Malaysia Sdn Bhd will not entertain any request for refund if :
 - I. In the event the vehicle take out from the storeyard without any Puspakom Inspection.
 - II. Engine changed and/or Engine Numbers differ;
 - III. Puspakom VR1 Inspection Report result is conditional passed report;
 - IV. Puspakom VR1 Inspection Report failed due to Joined Wheel House, Joined pillars and repaired accident unit without respective authority approval.
 - V. If the defects were found after the vehicle had been taken out from the storeyard even with failed Puspakom inspection
 - VI. The year and model in auction list does not tallies with the VOC or JPJ record. Bidders had been advised to check on their own and verify the vehicles details with the relevant authority before bidding.
 - VII. The transfer of ownership cannot be registered due to police traffic summons, JPJ blacklisted or registered under e-hailing.
 - VIII. any act / omission by the Bidder or his agents, servants or employees which had resulted in defects, loss, damages or seizure / forfeiture of the Vehicle by the Authorities after the delivery of the Vehicle to the Bidder.
6. All cost incurred including JPJ transfer of ownership of vehicle (DOUBLE TRANSFER / REPOSSESSED) will be borne by the buyer.
7. All documents related to ownership transfer (JPJ K3A,K3,K7,COMPANY REGISTRATION FORM) will be released within 14 days from the date of settlement of the full amount.



8. The release letter will only be issued in 3 working days after full payment is made.
9. If payment made via Cheque/Bank Draft/IBG, the bidder is only allowed to collect the Auction Vehicle after payment clearance.
10. All repairs costs will be borne by the bidder, and X Star Technology Malaysia Sdn Bhd shall not entertain any requests for compensation or reimbursement of such costs.
11. Auction deposit will be forfeited if full payment of the auction price is not received within 10 days after the auction date.
